  - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Wetland 1, does not have a surface or subsurface connection to a water of the United States. The wetland is within a moderate depression with no outlets. The wetland was determined to be geographically isolated. No surface connections are present between this wetland and any other waters. Desktop resources such as aerial photography, LiDAR derived elevation models and contours, and stream and wetland, were reviewed and we determined that there are no surface or subsurface connections between this wetland and other waters.

The Wetland 1 (0.39 acre) does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. This wetland does not have an ecological connection to other waters within or adjacent to the review area. The wetland was determined to not be jurisdictional under the CWA because the wetland lacked links to interstate commerce sufficient to serve as a basis for jurisdiction.
