- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The review area includes an approximately 10-acre site located at approximately 800 MN-7, in Prinsburg, Kandiyohi County, Minnesota. The property is currently used for agricultural production and gently slopes from high elevation on the northern side to a lower elevation on the southern project boundary. There are no mapped wetlands in the review area per the National Wetland Inventory (NWI). Per the offsite hydrology assessment conducted by Novel Energy Solutions, no wetland signatures were observed in the review area. This was confirmed during desktop review using the Google Earth imagery (2004, 2006, 2008, 2010, and 2015) submitted by Novel Energy Solutions. Therefore, the review area is composed entirely of dry land.
