The closest mapped water, a tributary to the Milwaukee River, is approximately 500 feet to the south on the other side of a residential road at approximately 948' in elevation. Each of the wetlands is located within a depression with W-2 at a low point between the 955' and 954' elevation contours while W-3 is at a low point between the 960' and 959' elevation contour lines. Based on the U.S. Geological Survey, Washington County GIS 1-foot elevation and FEMA map, these wetlands would not be flooded by an (a)(1)-(3) water in a | |
