- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains one wetland, labeled W-1 (0.09 acre). W-1 is a linear drainage ditch which was constructed with the construction of Hwy 31 around 2000 to drain surface water. W-1 was constructed in uplands and drains only uplands. This is supported by historic aerial photos and sample points from the supplied delineation report showing a lack of wetland signatures. Based on ground level photos from the report and aerial imagery, it does not carry relatively permanent flow. Although the soil type is mapped as being predominantly hydric, sample points immediately adjacent lack any wetland indicators. In accordance with the 2008 Rapanos guidance and the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following to be waters of the U.S.; non-tidal drainage and irrigation ditches excavated on dry land. Further clarification is provided in the December 2, 2008, Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States.**
