The Corps has determined that the features highlighted within the review areas shown on MVP-2012-02732-RJH Page 2 of 3 through Page 3 of 3 are not waters of the US. The jurisdictional determination for these features is in accordance with the pre-ambble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps does not generally consider the following to be waters of the US; artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing.**
