Wetland 1	0.7	acre(s)	(b)(1) Non- adjacent wetland.	Wetland 1 is contained entirely within the review area, surrounded by uplands and does not have any notable surface drainage offsite. This wetland was previously determined to be isolated and not under Corps jurisdiction (2015). The wetland is bordered by residential development, a residential road and active farmland. The nearest tributary is approximately 2,400 linear feet North of the site. A tributary is mapped south of the site but was not identified on aerial imagery. There is no single natural feature separating this site from the northern tributary as there is a long distance and no prominent natural features shown on topo maps between the resources. The wetland is not abutting this this tributary as the delineation shows the wetland boundary ending onsite. The wetland does not extend to a man made feature between the wetland and nearest identified tributary. The nearest tributary has a mapped 100 year FEMA floodplain which well north of the site. Wetland 1 does not abut an a(1)-a(3) water, is not separated from one by a natural or man-made feature and are not flooded in a typical year by an a(1)-a(3) water.
