- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The wetland delineation report submitted a National Wetland Inventory (NWI) figure that did not denote any wetlands within the project area. Additionally, review of the National Hydrography Dataset (NHD) did not show any surface water onsite. Soil maps submitted by the wetland delineator characterize the majority of the site as non-hydric soil. A small portion along the eastern edge of the site is hydric (Isanti fine sandy loam). The wetland delineator took a sample point within this area and determined it as not wetland based on a lack of hydrolog and hydric soils. Based on this information, the review area is not jurisdictional due to an absence of a water of the U.S.
