Explain: **The review area contains two aquatic resources (labeled as Wetlands 3 and 4 on Figures) that are isolated depressions with no surface or shallow subsurface connection to any waters of the U.S. The nearest tributary is an unnamed tributary to Apple Creek located approximately 1,900 feet to the east of Wetland 4. The surrounding land use consists primarily of agricultural fields, commercial development, and a paved roadway immediately to the north. These wetlands do not border, neighbor, nor are contiguous with another water of the U.S. They are not separated from other waters of the United States (WOUS) by man-made dikes, barriers, or berms. Due to their size and highly developed surroundings, Wetlands 3 and 4 provide limited habitat functions to WOUS and surrounding areas and provide no ecological connection.**

These aquatic resources do not support a link to interstate foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined these aquatic features are not regulated by the Corps under Section 404 of the Clean Water Act.
