Based on the wetland delineation report submitted by the requestor, aerial imagery, and LiDAR contours, we have determined that the wetland is isolated with boundaries that transition to uplands.**

Wetland 2 is located along the southern boundary of the site. Review of 2-foot LiDAR contours shows that the wetland is surrounded by uplands. Review of aerial imagery, historic USGS topographic maps, and the National Hydrography Dataset (NHD) support that there is not a surface water connection to a water of the U.S. (WoUS). The wetland is not mapped on the National Wetland Inventory (NWI). The soils are comprised of predominantly (60%) well drained angus type soil and a smaller (30%) fraction of poorly drained cordova type soil.

Wetland 2 does not support links to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. The wetland does not have an ecological connection to a WoUS. Furthermore, the area is hydrologically isolated with no surface water connections to a WoUS. Therefore, the Corps has determined that Wetland 2 is not regulated by the Corps under Section 404 of the Clean Water Act.
