Explain: **The review area contains one wetland (W-1) approximately 0.03 acre in size. This wetland is isolated, per review of materials provided by JSD Professional Services on September 2, 2021, which included a delineation map, 1-ft contours, Wisconsin Wetland Inventory map, NRCS soil survey, aerial photos, and ground level photos. The wetland is completely surrounded by upland with no inlets/outlets observed. The nearest WOTUS is an unnamed tributary to the Root River, approximately 450 feet to the southwest. There are no surface or shallow subsurface connections to another WOTUS.**

**The wetland does not border, is not neighboring to or contiguous with another water of the US. It is not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (agriculture) and proximity to other waters, there are no ecological connections to other wetlands or waters. This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W-1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
