- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The review area includes an approximately 10.5-acre site located near Minnesota Highway 7 and County Road 9 in Lester Prairie, McLeod County, Minnesota. Current land use on the site consists of row crop agriculture. There are no mapped wetlands in the review area per the National Wetland Inventory (NWI). The soils mapped in the review area are predominantly non-hydric. Per the offsite hydrology assessment conducted by Tetra Tech, no areas within the review area meet criteria for wetland hydrology. No surface waters are mapped within the review area per the National Hydrography Dataset. Therefore, the review area is composed entirely of dry land.
