Explain: **The review area contains one wetland.**

Wetland D (1,283 SF) is an isolated depression, located in a cropped field moving in the east-central portion of the property. Based on a review of recent aerial imagery, the wetland shows wet signatures in the growing season during multiple normal precipitation years. Review of the supplied materials from the applicant, along with historic aerial imagery and hillshade from LiDAR, show the wetland to be isolated. This wetland is an isolated depression, separated from other wetlands by upland features based on the delineation report and recent aerial photos. There are no surface or shallow subsurface connections between this wetland and any downstream waters, based on a review of recent aerial photos and topography showing an absence of any flow. Based on the delineation report, there are no inlets/outlets associated with the wetland. The nearest tributary to any of these wetlands is an unnamed tributary to the Fox River, approximately 0.10 miles to the east.

This wetland in the review area does not border or is neighboring to or contiguous with another water of the US. It is not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (residential development and ag use) and proximity to other waters, there are no ecological connections to other wetlands or waters. This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that the above-mentioned wetland is not regulated by the Corps under Section 404 of the Clean Water Act.

"Ditch Wetland" (487 SF) is a linear drainage ditch that was constructed in upland and drain only upland, evidenced by historic aerial photos and NRCS soil data. Based on aerial photos, it does not carry relatively permanent flow. In accordance with the 2008 Rapanos guidance and the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following to be waters of the U.S.; non-tidal drainage and irrigation ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States.
