The wetland is drained by an excavated ditch feature offsite that extends to the tributary within Wetland 15 to the west. This connection does not result in an adjacent wetland because Wetland 14 is adjacent to a man made ditch. While a portion of the ditch may have been constructed in wetland 14, the portion that connects to Wetland 15 was constructed in uplands. Wetland 14 is not abutting, or is not separated from a tributary by a natural or man made feature. Wetland 14 is not flooded by an a(1)-a(3) water in a typical year. |
