Wetland A	2.10	acre(s)	(b)(1) Non-adjacent wetland. Wetland A does not abut at least one point or side of, a paragraph (a)(1)-(3) water. There is not a natural or manmade berm, bank, dune or similar feature solely separating it from an (a)(1)-(3) water. Topographic and hill shade maps do not indicate above ground direct surface hydrological connection and support that Wetland A is not likely to be inundated by flooding from a paragraph (a)(1)-(3) water in a typical year. NHD and NWI maps confirm no surface hydrological connection to Wetland A. Therefore, the wetland does not meet the definition of an adjacent wetland under the NWPR and are not waters of the US.
