- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The wetland delineation report provides a soil review that categorizes the site as non-hydric and predominately non-hydric. Additionally, the National Wetland Inventory (NWI) map in the report does not show any wetlands present. Desktop review of the National Hydrography Dataset (NHD) does not show any surface water connections within the review area. Lastly, an aerial photo review was completed and submitted with the report that found no wet signatures in 21 aerial photos from 1937 to 2020. Based on this information, the review area is not jurisdictional due to the absence of a water of the U.S.
