Explain: **The review area for this jurisdictional determination includes one stormwater pond labeled as Wetland #1 on the attached figures labeled as 2022-02271-TJH Figures 1-5 of 5. Wetland #1 is a 0.02-acre stormwater pond that was designed and constructed in uplands. This was confirmed by reviewing historic aerial photos and the attached figures from the wetland delineation report, which show that the stormwater pond was constructed in cultivated uplands. The attached figures also demonstrate the stormwater pond was constructed in non-hydric soils.**

In accordance with the preamble to the 1986 Corps Regulations, Wetland #1 is not within the Corps jurisdiction because the Corps does not generally consider the following to be waters of the U.S.: artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing.
