There are no “*navigable waters of the U.S.*” within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Explain: **This AJD is limited to the boundaries of Wetland 2, as shown on the enclosed figures labeled MVP-2022-00916-SSC, Pages 1-2 of 2. Based on the wetland delineation report submitted by the requestor, aerial imagery, and LiDAR contours, we have determined that the wetland is isolated with boundaries that transition to uplands.**

Wetland 2 is a seasonally flooded, forested wetland located in the northwest corner of the site. The soils within this area are mapped as Angus-Cordova (partially hydric). The wetland is not mapped on the National Wetland Inventory (NWI). Review of the National Hydrography Dataset (NHD), aerial imagery, and historic USGS topographic maps does not show a surface water connection to a water of the U.S. (WoUS). LiDAR contours were reviewed for the site and indicate that Wetland 2 is located in a flatter break in the landscape as the area generally slopes to the north toward Beebe Lake Rd NE. Onsite observations from the wetland delineator note that the wetland is depressional and surrounded by uplands.

Wetland 2 does not support links to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. This wetland does not have an ecological connection to a WoUS. Furthermore, the area is hydrologically isolated with no surface water connections to a WoUS. Therefore, the Corps has determined that Wetland 2 is not regulated by the Corps under Section 404 of the Clean Water Act.
