Explain: **The review area for this jurisdictional determination includes one stormwater pond labeled as Wetland #1 on the attached figure labeled as 2022-02261-TJH Figures 2-3 of 3. Wetland #1 is a 0.13-acre stormwater pond that was designed and constructed in uplands by the Minnesota Department of Transportation in 1984 within the study area of Parcel ID: R152403351001 and the right-of-way to the west along 8th Avenue Southeast. This was confirmed by reviewing historic aerial photos and the attached figures from the wetland delineation report, which shows the stormwater pond was constructed in cultivated uplands and nonhydric soils.**

In accordance with the preamble to the 1986 Corps Regulations, Wetland #1 is not within the Corps jurisdiction because the Corps does not generally consider the following to be waters of the U.S.: artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing.
