W-2	0.03	acre(s)	(b)(1) Non-adjacent wetland.	W-2 is located at the edge of a farm field and has no inlets or outlets other than overland sheet flow. It does not abut at least one point or side of an (a)(1)-(3) water. Based on the Unites States Geologic Survey and elevation contours it would not be flooded by an (a)(1)-(3) water in a typical year. There is not a natural berm, bank, dune, or similar natural feature physically separating it from a paragraph (a)(1)-(3) water. It is not physically separated from a paragraph (a)(1)-(3) by an artificial dike, barrier, or similar artificial structure. Therefore, W-2 does not fall under Corps jurisdiction under the NWPR.
