Explain: **The review area contains one wetland (W-1) that is approximately 0.35 acre in size. The wetland extends outside of the review area to the north, so the area to the north was examined as well. This wetland is isolated, per review of the Wetland & Waterway Consulting wetland delineation report from April 2019, which included NRCS web soil survey data, Wisconsin Wetland Inventory map, aerial photography, ground level site photos, and wetland determination sheets. A Waukesha County GIS topographic map was also reviewed. The wetland lies in a shallow depression with residential development to the north, south, and west of it. The wetland appears to continue northeast towards another WWI mapped wetland area, however, this entire area is isolated. There are no observable inlets or outlets that connect the wetland to a water of the U.S. (WOUS) and there are no surface or shallow subsurface connections to another WOUS. The closest tributary is approximately 1,000 feet to the south. This wetland does not border, is not neighboring to or contiguous with another water of the US. It is not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (residential development) and proximity to other waters, there are no ecological connections to other wetlands or waters. This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that wetland 1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
