☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Two wetlands were assessed on a 43 acres parcel near Isanti, Minnesota. Wetland 2 and 3 are classified as type 1 seasonally flooded forest. Photography, LIDAR derived elevation models, contours, and stream and wetland mapping were used to conduct this review.**

Both wetlands do not have an outlet that leads to waters of the United States. Water infiltrates into the ground after precipitation accumulates from the surrounding uplands within their basins. Neither wetland contributes a surface or shallow subsurface connection to Waters of the United States (WOUS). We also determined that the wetland has no hydrologic or ecologic connection to a Navigable water of the U.S.

No industries or recreational activity has been established in the wetlands for the purpose of interstate or foreign commerce. The wetlands are considered isolated and do not support a link to interstate or foreign commerce. For these reasons, Wetlands 2 and 3 in the review area are not WOUS.
