Explain: The review area for this determination contains 13 roadside ditches labeled as wet ditch 1, 3, 4, 6, 7, 8, 9, 10, 11, 14, 15, 16, and 18 on the attached MVP-2019-02814-JRH AJD Attachments Pages 2-9 of 9.

The roadside ditches were constructed in uplands, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (WOTUS). Per the Rapanos decision, the evaluated ditches are not WOTUS because they are not tributaries and do not have a significant nexus to traditionally navigable waters. This was confirmed by reviewing aerial photography and the wetland delineation report dated November 2019.
