There are no “*navigable waters of the U.S.*” within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

The review area includes three aquatic resources (labeled as Wetlands 1, 4, and 5 on 2023-00088-JLK Figure 2 of 2) which are described as roadside ditches constructed in uplands sometime before 1957. A review of historical aerial photos shows no wet signatures were present within the footprint of the ditches prior to construction. All features traverse from north to south along the west and east sides of Loderbauer Road. The Wisconsin Surface Water Data Viewer shows there are no mapped wetlands or hydric soils within the review area and lidar data provided by the National Regulatory Viewer shows an increase in elevation on both sides of the features. A review of site photos illustrate a clear topographic increase on the west and east sides of these features, indicating the ditches drain only uplands. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following waters to be waters of the United States; non-tidal drainage ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in *Rapanos v. U.S.* and *Carabell v. U.S.* issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States. Based on this information, Wetlands 1, 4, and 5 are non-WOUS which are not subject to Corps jurisdiction under Section 404 of the Clean Water Act, or Section 10 of the Rivers and Harbors Act.
