Wetland 7	0.19	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 7 is an open water wetland that flows via buried culvert to a larger wetland basin that extends offsite. The wetland is surrounded by upland, as shown on figures with 2-foot lidar contours submitted in the wetland replacement application for the project. The culvert that drains Wetland 7 is not a tributary, confirmed by reviewing historic aerial images and topographic maps submitted by the agent. The wetland is not separated from an a(1)-a(3) water by only an artificial structure or natural feature. Based on this information, Wetland 7 is not a water of the U.S. under the Navigable Waters Protection Rule.
