There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Explain: **The review area contains two wetlands, W5 (0.030 acre) and W6 (0.002 acre). W5 is a wet meadow depressions dominated by dark-green bulrush and fox sedge. W6 is a depression surrounded by a road and housing development. Both of these wetlands are isolated, per review of the March 2016 Stantec Wetland Delineation Report, which included USGS 7.5' topographic map, NRCS soil survey data, Wisconsin Wetland Inventory map, aerial photography, and ground level site photographs. The two wetlands were examined for any inlets/outlets connecting them to another water of the U.S. (WOUS); none were observed. There are no surface or shallow subsurface connections to another WOUS. The closest WOUS is an unnamed tributary to Pebble Creek approximately 1,200 feet to the southeast.**

These wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (residential and agricultural development) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that wetlands 5 and 6 are not regulated by the Corps under Section 404 of the Clean Water Act.
