W01 is an engineered drainage ditch on the embankment of a constructed dam. The dam was originally constructed in 1887-1889 to provide power to an adjacent paper mill. The dam was reconstructed in 1937 to its current function and has been continuously operated since then. In 1989-1990, riprap and geotextile were added to the upstream face of the embankment and gravel drain and the drainage ditch were constructed along the downstream toe of the embankment. The gravel drain was engineered to direct seepage from the Wisconsin River through the embankment and into W01. W01 is not an (a)(2) water, it is not a relocated tributary, is not constructed in a tributary, and was not constructed in an adjacent wetland.
