A review of available information including the WWI, Google Earth, USFS Topo Mapping, etc., confirm that this wetland is an isolated wetland feature that does not maintain a surface water connection to an intermittent or perennial tributary. There are no culverts or other type of feature associated with this wetland which would create a hydrologic connection to a downstream tributary. W-3 is surrounded entirely by upland, therefore this wetland is physically removed from the nearest A(1) – A(3) water. There is no evidence that W-3 directly abuts an A(1)-A(3) water. Based on this information, W-3 is hydrologically isolated and is therefore not W-3 does not meet the NWPR definition of adjacency.
