| Wetlands A and B | 0.39 | acre(s) | (b)(1) Non-adjacent wetland. | Based on a review of the wetland delineation map, Wetlands A and B are in depressional areas surrounded by uplands in the south central and southeastern portions of a fallow field that extends east outside of the review area. Commercial development is located to the north, northeast, and south, and a paved four-lane roadway to the west. The delineation map also shows the boundaries of Wetland A is contained within the review area while the boundaries of Wetland B extends outside of the review area to the east. However, a review of aerial photos provided via Google Earth indicates Wetland B does not extend further than the fallow field and is surrounded by uplands involving commercial development. Historical aerial photos provided in the delineation report and via Google Earth (photos taken 06/2015, 07/2011, 06/2010, 10/2010, 07/2010, 06/2008, 06/2006, 05/2005, 04/2004, 05/1992) primarily taken during the wetter months of the year, illustrate mostly dry conditions within the area. The Wisconsin Surface Water Data Viewer indicates the nearest (a)(1)-(a)(3) water is an unnamed tributary of the Sheboygan River approximately 0.39 mile northeast of the review area. A review of floodplain maps indicate there is no mapped floodplain for this tributary and a review of a topographic map provided via Sheboygan County GIS demonstrates a decrease in elevation from 682 to 680 near the tributary to the northeast. The presence of uplands around both wetlands, the change in elevation, the lack of a mapped floodplain within the review area, and aerial photography, all indicate these wetlands do not abut the tributary to the northeast, are not separated from this water by natural or man-made barriers, and do not receive flooding in a typical year from this water of the U.S. |
