The joint application states that Wetland A (Pond 17) was constructed in an area described as a historical wetland, and is currently used as a stormwater pond. Contour maps submitted in the joint application indicate that Wetland A is an isolated depression and is not abutting an a(1)-a(3) water. Therefore, Wetland A is not considered a water of the U.S. under the Navigable Waters Protection Rule.
