Explain: **The review area contains 2 aquatic resources (labeled as Wetland 1 and 2 on Figures) that are isolated wetlands with no surface or shallow subsurface connection to any waters of the U.S. including the nearest aquatic resource which is Bear Creek located approximately 1.5 to the NW. These wetlands do not border, neighbor, nor are contiguous with another water of the U.S. They are not separated from other waters of the United States (WOUS) by man-made dikes, barriers, or berms. Wetland 1 and 2 are completely surrounded by upland. The surrounding land use consists largely of agriculture use. Due to the quality, community type and small sizes, Wetland 1 and 2 provide limited habitat functions to WOUS and surrounding areas and provides no ecological connection.**

**This aquatic resource does not support a link to interstate foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined this aquatic feature is not regulated by the Corps under Section 404 of the Clean Water Act.**
