**C.** Additional comments to support AJD: The aquatic resource being evaluated is Wetland 3 (0.026 acres) shown on the attached figure labeled MVP-2020-01092-EJW AJD Figures Page 2 of 3. The review area for this determination included only Wetland 3. Based upon information gathered as a result of the desktop review and the wetland delineation report, Corps staff determined that Wetland 3 is wholly surrounded by uplands and lacks an unbroken surface connection to a water of the United States. Wetland 3 does not abut a TNW, tributary, lake, pond, or impoundment of a jurisdictional water in a typical year. Therefore,

<sup>&</sup>lt;sup>5</sup> Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
