The wetland is surrounded by upland, as shown in the wetland delineation. This shows the wetland does not continue to abut an a(1)-a(3) water. The nearest tributary is approximately 610 linear feet north of the wetland and topographic maps show that there is no single natural feature separating the wetland from an a(1)-a(3) water. The wetland is outside of the 100 year flood plain of the nearest tributary and also outside the Apple Creek 100 year floodplain.
