Based on a review of available resources including the Wisconsin Wetland Inventory Mapping, Google Earth Aerial Imagery, USGS Topographic Mapping, the USGS Web Soil Survey, Wisconsin Surface Water Data Viewer, etc., we have determined that the resources listed above are isolated/non-adjacent wetlands which do not meet the definition of “adjacent wetlands”. These features are (b)(1) Non-adjacent wetlands which do not maintain a hydrologic connection to a downstream TNW. These features are not inundated by flooding from an (a)(1)-(a)(3) water in a typical year, nor are they separated from these types of features from a natural or man-made barrier. A review of the Wisconsin Surface Water Data Viewer indicates two unnamed tributaries are situated in close proximity to the review areas. However, neither of these tributaries maintain a hydrologic connection to the aquatic resources identified above. These resources are best described as hydrologically isolated features with boundaries that transition into uplands. A review of the available topographic maps indicate that surface water within the review area generally flows towards these unnamed tributaries. However, none of the aforementioned aquatic resources maintain a hydrologic connection to these tributaries. Further, there are no culverts or other type of feature associated with any of these wetlands which would create a hydrologic connection to a downstream tributary. These wetlands are surrounded entirely by uplands, and are therefore physically removed from the nearest (a)(1)-(a)(3) water.</p> <p>Based on this information, the wetlands</p>

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
