D. ADDITIONAL COMMENTS TO SUPPORT JD: The review area for this determination is limited to the boundaries of 25 roadside ditches labeled as Wet Ditch (WD) 1, WD 2, WD 3, WD 4, WD 6, WD 8, WD 9, WD 10, WD 11, WD 12, WD 15, WD 18, WD 19, WD 20, WD 21, WD 26, WD 27, WD 28, WD 29, WD 30, WD 31, WD 34, WD 35, WD 36, and WD 37 on the attached figures and tables labeled MVP-2019-00842-BGO MnDOT SP 5208-22/TH 111 and SP 5205-112/TH 22 AJD Attachments, Pages 1-25 of 25. All of the labels for these aquatic resources are also highlighted in yellow on the attached figures. The totat area of non-jurisdictional waters/features is approximately 0.60 acre.

The ditches are constructed features that are not relocated tributaries, are not excavated in a tributary, and do not convey perennial or intermittent flow. This was confirmed by reviewing aerial photography, national hydrography data, and the wetland delineation information included with the April 2018 Joint Application Form. Based on this review, the evaluated ditches are not jurisdictional under the 2015 Clean Water Rule because they meet the terms of paragraph (b)(3)(i).

¹ In many cases these excluded features will not be specifically identified on the approved JD form, unless specifically requested. Corps Districts may, in case-by-case instances, choose to identify some or all of these features within the review area.
