Wetland 1	0.04	acre(s)	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	Wetland 1 is characterized in the wetland delineation report as a dry stormwater detention basin constructed on the property at the time the parcel was developed. This is also supported by historic aerial imagery from 1937 and 1945 (MHAPO). The soil figures included in the report characterized this wetland as Lester-Kilkenny complex, 6 to 10 percent slopes moderately eroded (well drained, non-hydric soil). Wetland 1 is also surrounded by upland as shown on the 2-foot LiDAR contours figure submitted in the wetland delineation report. Based on this information, Wetland 1 is not a water of the U.S. under the Navigable Waters Protection Rule (NWPR).
Wetland 2	0.03	acre(s)	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	Wetland 2 is a linear ditch feature that is located within the right-of-way of Highway 7. The wetland receives hydrology from the adjacent uplands and Highway 7 surface. The soil is characterized as Hamel-Glencoe complex, 0 to 2 percent slopes (poorly drained, hydric soil). Review of historic aeries (MHAPO 1937) and historic topographic maps (Minnetonka 1905) were reviewed prior to Hwy 7 being constructed in its current alignment. The aerial and topo map indicate that wetlands were historically present however, those wetlands do not appear to be adjacent at the time of construction (a(4) wetland). Additionally, review of recent Google Earth imagery does not show a surface water connection to an a(1)-a(3) water and the National Hydrography Dataset also supports this review. Based on this information, Wetland 2, is a not a water of the U.S. under the NWPR.
