WB-01	0.05	acre(s)	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	The wetland delineation report states that WB-01 is a ditch that was originally excavated in upland to convey surface water from WB-03 to the north, under a field road. This ditch (WB-01) currently conveys water north under Sparrow Road. WB-01 is not found in 1951 aerial imagery submitted in the wetland delineation report and the area where WB-01 is currently located appears to be upland. WB-01 is a ditch that was created in uplands and is not a naturally occurring surface water channel or relocated tributary. Based on this information, WB-01 is not a water of the U.S. under the Navigable Waters Protection Rule.
WB-03 and WB-05	0.42	acre(s)	(b)(1) Non-adjacent wetland.	Contour maps submitted in the wetland delineation indicate that WB-03 is located in an isolated depression and only shares a direct hydrological surface water connection with WB-01, a non-jurisdictional ditch (see above). WB-05 appears to have formed after the construction of the residential development located north of the wetland. Contour maps and aerial imagery in the wetland delineation indicate that WB-05 is a depressional basin surrounded by upland. WB-03 and WB-05 are not adjacent to an a(1)-a(3) water. Therefore, WB-03 and WB-05 are not considered waters of the U.S. under the Navigable Waters Protection Rule.
WB-02 and WB-04	0.72	acre(s)	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	The wetland delineation states that WB-02 is a stormwater control features that was constructed in upland as part of the Waterford residential development project. Aerial imagery in the wetland delineation confirms that WB-02 was constructed in upland between 2004-2006. Aerial imagery also confirms that WB-04 was constructed in upland between 2008-2009. WB-02 and WB-04 are stormwater control features constructed in uplands. Therefore, WB-02 and WB-04 are not considered waters of the U.S. under the Navigable Waters Protection Rule.
