Wetlands A, B, and C	1.52	acre(s)	(b)(1) Non-adjacent wetland.	These wetlands do not meet the definition of adjacent wetlands. They do not abut a traditional navigable water, tributary, or a lake, pond, or impoundment of a jurisdictional water in a typical year. The nearest potential jurisdictional water is County Ditch 58 located 0.14 miles east of the project site. They would not be flooded by an (a)(1)-(3) water in a typical year. Google Earth imagery did not show a hydrologic connection in any photographs from 1991 through the most recent photo in October 2019. There is not a natural or artificial berm, bank, dune or similar feature solely separating these wetlands from an (a)(1)-(3) water, and topographic maps do not indicate a drainage way from these wetlands to a jurisdictional feature.
