Rationale for Exclusion Determination **Exclusion Name Exclusion Size** Exclusion⁵ Wetland F 0.10 acre(s) (b)(1) Non-Wetland F is a seasonally flooded type farmed adiacent wetland basin. This wetland is an isolated basin with wetland. no direct hydrologic connections to downstream waters. This was confirmed by reviewing the wetland delineation that was completed for the project, NWI and soils maps, as well as historic and current aerial and lidar imagery. The soils map provided in the wetland delineation indicates a larger hydric soil unit abutting the ditch feature flowing through the center portion of this property. Wetland F is located within that soil unit, but was delineated in the field as a separate, isolated wetland basin. Corps staff reviewed the delineated wetland boundaries for this project site in the field on May 30, 2018. The Corps concurred with a revised delineation report submitted for the project dated July 24, 2018 in a letter dated August 14, 2018. The wetland does not contain any known drainage infrastructure that could potentially connect it to downstream waters. Wetland F is physically separated from potential downstream waters. It is not located within the floodplain of any larger downstream waters and is not separated from downstream waters by an artificial barrier. Wetland F is hydrologically isolated and physically remote and does not qualify as an (a)(4) adjacent water.
