The excavated feature was constructed between 2006 and 2008. It appears to be directly associated with stormwater treatment for directly adjacent residential development. Aerial photos prior to 2006 show an upland landscape with no wet signatures in the agricultural lands where the pond was constructed.
Wetland B	1.45	acre(s)	(b)(1) Non-adjacent wetland.	This feature may have periodic surface drainage to a ditch feature south of the site. This drainage feature appears to have been constructed between agricultural fields and would not be a a(1)-a(3) water. Tributaries exist to the NW and SE of the site. The wetland feature does not extend to either of these features. This wetland does not abut an a(1)-a(3) water, is not separated from one by a natural or man-made feature and are not flooded in a typical year by an a(1)-a(3) water.
