Wetland 1	0.08 acres	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff	Wetland 1 is isolated, with no connectivity to adjacent wetlands and/or aquatic resources and no discernable inlets or outlets nor are there any identified culverts. According to the memorandum, during construction of a housing development east of the proposed project location, Wetland 1 was created as a stormwater pond. Before the construction of the development, no evidence of Wetland 1 is visible in the historic imagery. A review of Google Earth imagery confirmed that Wetland 1 was constructed sometime between 2006 and 2008. Based on this information, Wetland 1 is not considered a water of the U.S. under the Navigable Waters Protection Rule.
