Based on the U.S. Geological Survey, City of Janesville GIS 2-foot elevation contours and FEMA map, these wetlands are depressions situated within the 894' elevation contour with no inlets or outlets and would not be flooded by an (a)(1)-(3) water in a typical year. There is no natural berm, bank, dune, or similar artificial structure physically separating these wetlands from an (a)(1)-(3) water. The nearest waterway is an unnamed intermittent tributary approximately 0.75 miles to the south of the review area.
