$\boxtimes$	The review area is comprised entirely of dry land (i.e., there are no waters or water features, including
	wetlands, of any kind in the entire review area). Rationale: The review area includes a parcel
	measuring approximately 36 acres located north of 130th St W in Shakopee, MN. The National
	Wetlands Inventory (NWI) indicates no wetland areas as being mapped within the survey area and the
	MN DNR Public Waters Inventory Map indicates there are no public waters within the survey area as
	well. The National Hydrography Dataset (NHD) does not indicate any wetlands, watercourses or other
	waterbodies within the review area. The Scott County Soil Survey indicates predominately non-hydric
	soils in the review area. Data provided in a wetland delineation report supports that soils were non-
	hydric. The agent completed a site assessment that included sample points. The sample points
	confirmed a lack of dominance of hydrophytic vegetation, hydrology and soil wetland indicators.
