Contour maps submitted in the Wetland Delineation Report: Kandiyohi County CP 40-23-9 Realignment Project show that these wetlands are depressional features, completely surrounded by uplands. Aerial imagery from the submitted delineation report and Google Earth confirms that these wetlands not abutting an a(1)-a(3) water and that there is no channelized surface water connection from Wetland W-A and W-B to an a(1)-a(3) water. Therefore, Wetlands W-A and W-B are not considered waters of the U.S. under the Navigable Waters Protection Rule.
