Based on aerial photos, site photos, USGS Quadrangle Map, Google Earth Street View and Wisconsin Surface Water Data Viewer, Wetland 1a, 1b, and 3 are ditches that do not have perennial or intermittent flow. These ditches do not meet the criteria as (a)(1) or (a)(2) waters. The Evergreen Consultants Wetland Delineation Report describes the features as ditches that were excavated in fill soils. Aerial photos and NRCS Soils Map also indicate that these ditches were not constructed in an (a)(4) water. Wetland 1b does extend to the southwest out of the review area but the ditch does not overlap with a mapped tributary or an adjacent wetland. These ditches were not constructed in an (a)(4) water.	
Wetland 2	0.003	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 2 is surrounded by upland with no inlets/outlets and does not abut one point or side of an (a)(1)-(3) water. Overland sheet flow from surrounding upland could flow towards this depressional area. According to Waukesha County GIS, the closest mapped tributary is an unnamed tributary to Poplar Creek located over 1715 linear feet away feet and 3.6 feet lower in elevation. Based on the 1-foot contour map, site photos, surrounding development, distance to the nearest mapped tributary, and the FEMA map, W-2 would not be flooded by an (a)(1)-(3) water in a typical year. There is no natural or artificial berm, bank, dune or similar feature that is physically separating this wetland from an (a)(1)-(3) water.
