This determination is limited to Wetland 1, Wetland 2, Wetland 3, and Wetland 4 in the approximately 73-acre study area as shown on MVP-2020-02325-KDZ, Figure 1. Based on a review of the Wisconsin Wetland Inventory, USGS Topographic Map, USDA NRCS Soil Survey, and November 2020 MSA Wetland Delineation Report, Wetland 1, Wetland 2, Wetland 3, and Wetland 4 are entirely surrounded by uplands, thereby eliminating direct hydrologic connections between all four wetlands and an NWPR tributary during a typical year. Wetland 1, Wetland 2, Wetland 3, and Wetland 4 do not meet the NWPR definition of adjacency.
