According to contour, National Wetland Inventory, and National Hydrography Dataset maps the pond was is an enclosed basin in upland with no inlet or outlets. A USGS map of the area made in 1901 shows the property as upland only. Aerial imagery from 1956 and 1971 also shows no pond or wetland on the property.
