Wetlands 1 and 2	0.33	acre(s)	(b)(1) Non-adjacent wetland.	Based on a review of the wetland delineation map, Wetlands 1 and 2 are surrounded by uplands in the central portion of a vacant field. Agricultural fields and a man-made storm water pond are located to the east, industrial development to the north and south, and a paved two-lane roadway to the west. The delineation map also shows the boundaries of Wetlands 1 and 2 are contained within the review area and additional wetlands outside of the review area to the north. Historical aerial photos provided in the request and via Google Earth (photos taken 05/2018, 04/2017, 04/2015, 10/2013, 05/2011, 06/2010, 06/2008, 06/2006, 05/1992) primarily taken during the wetter months of the year, illustrate mostly dry conditions within the area. The Wisconsin Surface Water Data Viewer indicates the nearest (a)(1)-(a)(3) water is an unnamed tributary of Black Otter Creek approximately 0.02 mile north of Wetland 2. A review of floodplain maps indicate there is no mapped floodplain for this tributary and a review of a topographic map provided in the wetland delineation to the north shows a gradual decrease in elevation towards the north/northwest. The presence of uplands around both wetlands, the change in elevation, the lack of a mapped floodplain within the review area, and aerial photography, all indicate these wetlands do not abut the tributary to the north, are not separated from this water by natural or man-made barriers, and do not receive flooding in a typical year from this water of the U.S.
