Excluded waters ((b)(1) – (b)(12)):⁴ The review area for this determination includes 12 wetlands labeled as Wetland 2B, 10J, 12B, 20E, 20H-20I, 23B, 23E, 23H, 23J-23K, and 32B and 85 roadside ditches labeled as Wet Ditch 1A-1D, 2A, 2C, 3, 4A-4B, 4D-4E, 4G, 5, 6C, 7-9, 10A, 10D, 10F-10I, 10K, 11, 12A, 13, 14A-14D, 14F-14G, 14I-14K, 15-18, 20A-20D, 20F-20G, 21, 22A-22B, 23A, 23C-23D, 23F-23G, 23I, 23L-23M, 24, 25A-25B, 26A-26C, 26E-26G, 26I-26J, 27A-27C, 28, 29A-29B, 30A-30B, 31A-31B, 32A, 32C-32E, and 32H-32J on the attached figures labeled as 2021-00503-BGO AJD Attachments, Pages 1-44 of 44. All the labels for these waters are also highlighted in yellow on the attached figures.

All these wetlands are surrounded by uplands and non-jurisdictional roadside ditches and do not have a direct hydrologic surface connection to downstream waters.</p> <p>Wetlands 23B, 23E, 23H, and 23J-23K are connected by culverts and non-jurisdictional roadside ditches and are part of a larger NWI mapped wetland area located at the intersection of TH 212 and 200th Street. However, this larger wetland area is also an isolated basin that is physically separated from potential downstream waters.</p> <p>This was documented in the delineation that was completed for the project site and confirmed by reviewing the enclosed national wetland inventory, hydric soil, and topographic mapping for the project site. The assessed wetlands do not abut jurisdictional waters, are not inundated by flooding from a traditional navigable water, or tributary, or from a jurisdictional lake, pond, or impoundment, and are not physically separated from a jurisdictional water by only a natural feature or artificial structure that allows for a direct hydrologic surface connection. Based on this review, the assessed wetlands are not jurisdictional under the Navigable Waters Protection Rule (NWPR) because they meet the requirements of the exclusion for non-adjacent wetlands under paragraph (b)(1).</p>

⁴ Some excluded waters, such as (b)(2) and (b)(4), may not be specifically identified on the AJD form unless a requestor specifically asks a Corps district to do so. Corps districts may, in case-by-case instances, choose to identify some or all of these waters within the review area.

⁵ Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

This was confirmed by reviewing aerial photography, national hydrography data, and the wetland delineation report. Based on this review, the assessed ditches are not jurisdictional under the NWPR because they meet the requirements of the exclusion for ditches under paragraph (b)(5).
