After reviewing the Wisconsin Surface Water Data Viewer, Wisconsin Wetland Inventory and hydric soils layer indicating no wetlands or waterways, the remainder of the site was confirmed to contain no wetlands or other surface waters during a site visit on August 2, 2021.
