The aquatic resource is a storm water pond that serves as a regional storage pond for commercial developments and was constructed sometime between 1995-2000, based on historic aerial photos. Wisconsin Wetland Inventory also shows the pond as “excavated”. Aerial photos show that the pond was constructed in agricultural upland because there are no wet signatures to indicate wetland hydrology in most years (1941, 1950, 1980, 1990, 1995) and the ag field matches other ag fields in the surrounding area. The pond is also not an impoundment of jurisdictional water.
